

The basic course in Law is One Year P.G Diploma in (Cyber Law, Law & Medicine, Human Rights and IPR) followed by Degree/Graduate program, Bachelor In Law (BBA-LL.B- 5yrs,BA-LL.B- 5 yrs) and post graduate programs in (LL.B- 3Yrs) , (LL.M 1 yr) and also doctorate in Law i.e PhD In Law. These programs/ courses are duly approved by Bar Council of India (BCI) and affiliated to Uttarakhand Technical University (UTU) as well recognized by the Government of Uttarakhand.

Foundation Degree in B.A.LL.B. 5 Yrs



BA-LL.B. 5 years Integrated Course

Course Duration: 5 years 10 semesters

Eligibility: 10+2 in any discipline with min 45% marks
(General Category and 40% for SC/ST)

Seats: 60

Introduction

It is integrated course of law where students get the opportunity to simultaneously study law and humanities.

The allied subjects offered under this course are English, Political Science, History, Sociology, business studies and management.

It is a five year course comprising ten semesters on completion of which a student earns a graduate degree in law.

Programme Content

B.A. LL.B. integrated double degree course, combines Bachelor's degree course in Arts together with the Bachelor's degree course in law. The duration of the course leading to the Bachelor's Degree in Law (LLB) shall be of five academic years. Each academic year comprises of two semesters.

A student who successfully completes the first three years of this course shall be eligible for the award of the Degree BA (Academic Law). A student who successfully completes the five year LLB, Course shall be eligible for the award of the Degree of LL.B.

Entry Requirements

The applicant should have passed 10+2 or its equivalent examination in any stream. Should have secured minimum 45% of marks in case of general categories of applicants and 40% marks in case of SC/ST applicants.

Maximum age for seeking admission to this course is twenty years in case of General Category of applicants and twenty two years in case of applicants from SC/ST/OBC. Such age shall be counted on the 1st July of academic year of the admission. Only high school certificate will be considered for age proof and no other documents will be taken into consideration for age proof.

Assessment

It provides for compulsory practical training and mandatory Moot Court practice.

Foundation Degree in BBA.LL.B 5 Yrs



BBA-LL.B. 5 years Integrated Course

Course Duration: 5 years 10 semesters

Eligibility: 10+2 in any discipline with min 45% marks
(General Category and 40% for SC/ST)

Seats: 60

Introduction

The Sweeping changes in the global Economic scenario have necessitated a strong demand for a breed of youngsters with the potential knowledge of law coupled with the core essentials of Management & Business to enhance productivity. With the object of catering to this demand unfolding before the students, and to enable them to explore these vistas of opportunities that lie ahead, The Management of the college has commenced an Integrated Bachelor of Business Administration and Bachelor of Law degree Programme (BBA, LL.B).

Program Content

BBA-LL.B. provides an integrated understanding of the inter relation of management studies and law in their entirety than in specified areas. Honors in Business Administration covers a vast domain of the contemporary areas of managerial relevance and provide the students an opportunity to focus on strategies to manage business in fast-evolving global environments, with a strong emphasis on entrepreneurship, the impact of technology on commerce, managing the emerging markets of Asia and other global issues. Study of these courses will enable the students to develop a competitive edge over their counter parts in other institutions and help in taking them to the zenith of their career.

Entry Requirements

The applicant should have passed 10+2 or its equivalent examination in any stream. Should have secured

minimum 45% of marks in case of general categories of applicants and 40% marks in case of reserve category applicants.

Maximum age for seeking admission to this course is twenty years in case of General Category of applicants and twenty two years in case of applicants from SC/ST/OBC. Such age shall be counted on the 1st July of academic year of the admission. Only high school certificate will be considered for age proof and no other documents will be taken into consideration for age proof.

Assessment

It provides for compulsory practical training and mandatory Moot Court practice.

Progression

Degree in LL.B. 3 Yrs



LL.B. : 3 years Course

Course Duration: 3 years 6 semesters

Eligibility: Graduation in any discipline with min 45% marks (General Category and 40% for SC/ST)

Seats: 60

Introduction

The course is designed for serious minded students who are competent to pursue research oriented study and have an inclination towards academics.

Program Content

In India, legal education has been traditionally offered as a three-year graduate degree conferring the title of LL.B. (Bachelor of Laws) or B.L. (Bachelor of Law). However the legal education system was revised by the Bar Council of India, the governing body of legal education in India in 1984. Pursuant thereto, various autonomous law schools were established that administer a five-year (5 year) undergraduate degree programme and confer an integrated honours degree, such as "B.A., LL.B. (Honours)", "B.B.A, LL.B. (Honours)", "B.Sc., LL.B. (Honours)", etc.

Both the types of degrees (i.e., three-year and five-year integrated honours) are recognized and are also qualifying degrees for practice of legal profession in India. A holder of either type of degree may approach a Bar Council of any States of India and get upon compliance with the necessary standards, be enrolled on the rolls of the said Bar Council. The process of enrolment confers a licence to the holder to practise before any court in India and give legal advice. The entire procedure of enrolment and post-enrolment professional conduct is regulated and supervised by the Bar Council of India.

Entry Requirements

Graduation in any stream with minimum 50% marks in case of candidates from general categories and 45% marks in qualifying examination in case of SC/ST candidates.

Assessment

It provides for compulsory practical training and mandatory Moot Court practice.

Progression

The students who have inclinations towards public speaking and have interest in political and social affairs of the country and the world, will find a suitable course study in this discipline. We offer well conceptualized course content relevant to the requirements of the existing legal system; in a world class learning environment with emphasis on internship in the courts and moot courts.

Master Degree in LL.M. 1 Year



LL.M: 1 year Course

Course Duration: 1 year 2 semesters

Eligibility: LL.B with min 55% marks (General Category and 45% for SC/ST)

Seats: 24

Introduction

The course is designed for serious minded students who are competent to pursue research oriented study and have an inclination towards academics.

Programme Content

LL.M. degree prepares the students for a satisfying career in various branches of law, such as law officers, legal advisors, law professionals having independent set-up.

LL.M. degree also qualifies a person for teaching in a law school and university. They can also take judicial service examination and become judges. There is no dearth of career opportunities for LL.M. degree holders.

Entry Requirements

Three years or Five years Degree in Law with minimum 55% marks in case of candidates from general categories and 45% marks in qualifying examination in case of SC/ST candidates.

Assessment

Courses are taught in a variety of formats, including seminars, lectures and small group classes.

Progression

This allows students to graduate with named awards reflecting their own specialism's and interests, such as an LL.M in a single subject, a joint LL.M, or an LL.M with a major and minor subject. Students can also obtain a general LL.M by selecting modules from a wider number of subject areas to reflect their needs and interests.



Doctorate in Law Ph.D.

Doctorate in Law is the latest Course introduced by SLC.

Details of the Course

DESIGNATION OF THE COURSE: The PhD degree awarded by the Uttarakhand Technical University, (UTU) shall be designated as Doctor of Philosophy in Law.

The certificate shall not indicate the subject or specialty. The **TITLE OF THE THESIS** shall be indicated in the certificate.

Eligibility for Admission

1) A candidate seeking admission to the course of study leading to the award of a degree of Doctor of Philosophy (Ph.D.) must possess at least one of the following qualifications:

2) Masters degree in law with 55% marks in case of General & OBC Category and 50% in case of SC/ST Category

3) The candidate must have also obtained 50% marks in case of General & OBC Category and 45% in case of SC/ST Category in Research Entrance Test (RET) conducted by the university in consonance with UGC Regulations.

4) Any other modification in eligibility criteria will be considered, if recommended by the Academic council (AC) of UTU and UGC.

5) After result of RET is declared, the merit list of the successful candidates shall be prepared based upon the available vacancies taking into consideration the reservation policy.

Procedure of Registration

The candidate will be admitted to Ph.D. program when he or she qualifies the written test with 50% marks in case of General & OBC Category and 45% in case of SC/ST Category. The test will be conducted by UTU every six months or as notified. The syllabus will be similar to GATE/NET/GPAT/JRF. Normally 60 multi choice questions shall be asked from the candidate on research & legal aptitude. Duration of the RET shall be one hour. Pattern will be similar.

Continuation of Scholarship

Scholarship is granted on annual basis and continuation in second and further years of the program is subject to scholarship policy. To continue availing 100% scholarship student must top the university exam with 85% and above in the annual examination without back in any subject. For continuation of 50% scholarship, student must top the university exam with 80% and above in the annual examination without back in any subject. For continuation of 25% scholarship, student must top the university exam with

75% and above in the annual examination without back in any subject.

2) Academics,



3) Regulatory Affairs

The Foods & Drugs Control Administration (FDA) is the main regulatory body governing and implementing the rules and regulations for the Drug and Pharmaceutical substances world wide. The FDA has state branches and sub-branches all over the country. Medicines in India are regulated by Central Drugs Standard Control Organization and the pharmaceutical products through Drugs Controller General of India. 

Introduction

Diploma in Pharmacy, popularly known as D. Pharm or D. Pharma, is a two-year undergraduate diploma course offered by pharmacy colleges in India. The course is the minimum qualification to become a registered pharmacist in the country.

D. Pharma doesn't provide specialization to choose from; only the basic concepts of pharmaceutical science are taught in this course. After successfully completing two years of D. Pharma and after registering with Pharmacy Council of India (PCI) or the state Pharmacy Council, one can set up his/her own pharmacy/chemist, in order to stock and sell medicines and dispense them according to a registered medical practitioner's prescription. One can also become medical representative after pursuing the course.

Programme Content

The course of study in Diploma in Pharmacy comprises of Part-I and Part-II. There shall be an examination in the first year on the subjects of Part-I and an examination in the second year comprising the Part-II subjects.

Entry Requirements

Pass with 45% aggregate marks in 10+2 or equivalent (with English, Physics, and Chemistry & Math/Biology). Condition of English may be waived off in case student has studied in English medium or may be replaced in case studied Computer Science as a subject.

Assessment

A regular record of both theory and practical class work and sessional exams are maintained.

Introduction

The course is designed to integrate the teaching, learning and understanding of pharmaceutical science in the context of pharmacy practice. It will provide you with opportunities to become confident and competent professional committed to lifelong educational development. To summarize it is advancement over B. Pharm. Programme.

Programme Content

The course is of two years duration. The first year curriculum is designed with exposure to advances in pharmacology, wherein the candidate has potential to equip himself/herself with all preclinical pharmacological, toxicological and safety pharmacological studies. Furthermore, he/she gets adequate exposure of clinical research methods, newer molecular biology techniques.

The second year is mainly through dissertation on the topic of industrial research and development, new drug discovery etc. Thus the two year program will enable pharmacology student to cope up with present day need of preclinical and clinical research in new drug discovery and development.

M.Pharm or Ph.D holders are normally absorbed in research work, to develop new useful drugs, in laboratories and in production work in pharmaceutical industry and analyzing them for purity and strength. Pharmacist may also take up teaching as a profession as lectures in pharmacy colleges and universities.

The M.Pharm graduates can join a public sector firm in the Junior Executive post available in various departments like production department and quality

control department. They can get into the post of Deputy Manager and then Manager after getting much experience. Those who are working as Junior Pharmacist can get into the post of Senior Pharmacist if their knowledge and experience suits the senior post. The aspirants who have chosen the teaching profession can join any government institution as lecturer. The next higher designation available for the lecturer is Assistant professor. Assistant Professor can get into the post of Senior Professor after getting adequate experience.

Assessment

Assessment includes written examinations at the end of each year. All courses also have continuous assessment that contributes the remainder of the overall course mark. Continuous assessments include practical dispensing examinations, objective structured clinical examinations, presentations (individual and group), written reports, assessment of laboratory notebooks, case studies, essays and multiple choice questions. Final honours classification is calculated from: 10% of Stage 2 overall grade, 40% of Stage 3 overall grade and 50% of stage 4 overall grades.

Introduction


M. Pharm (Pharmaceutical Chemistry) is supposed to be one of the important branches of Pharmacy. It is a two-year full time course. While pursuing this course, the student will learn basic pharmaceutical chemistry, organic chemistry, basic pharmaceutics and pharmacology, pharmaceutical technology, advance pharmaceutical chemistry, basic physiology and pharmacognosy etc.

Programme Content

The discovery of drugs has always been the aim of pharmaceutical sciences and, in particular, of pharmaceutical chemistry. The progress and development of this field of research has made medicinal chemistry, the modern and enormously productive science in recent decades. This course is focused not only on discovering new biologically active compounds using sophisticated techniques but also on gaining a better understanding of how and where drugs exert their effects at the molecular level.

Entry Requirements

Eligibility for the program is B.Pharma with 50% and valid GPAT score. Industry sponsored candidate would be preferred. Candidates without GPAT score will also be considered if seats remain vacant.



Training & Placement of the Students

SIP has an active training and placement cell which invites experts from the industry to deliver lectures and conduct placement talks with the students. The BCA Program at the university is foundation oriented with high practical component. It aims to produce graduates with strong fundamentals of theory and practical aspects of information technology and computers.


The course lays emphasis on various programming languages. The University maintains a high standard of teaching in classrooms and computer laboratories with a highly qualified and experienced faculty.

FEE STRUCTURE

Payment of Fee

Following shall be the payment of fee schedule for different programmes:

All the students are provided admission on the payment of full fees for the academic year at the time of admission and for second academic session before the commencement of the classes for second academic session and so on.

In appropriate cases, it can be divided into two installments wherein for the FIRST SESSION the 1st installment must be paid at the time of admission and 2nd installment before 15th of January.

Likewise, for SECOND SESSION, 1st installment before the commencement of the classes and 2nd installment before 15th January and so on.

Note: In case the payment of fee is allowed in two installments (semester-wise) and any student does not comply with the deadlines set by the SGI, a fine of Rs. 100/- per day shall be levied for a maximum period of 15 days after which they shall not be permitted to attend their classes and their examination forms shall not be forwarded to the University for which the candidate and their parents alone shall be responsible.

RULES AND REGULATION

Do's

- You are required to attend the classes and complete your assignments regularly. Your 100 % attendance is solicited. However, some relaxation may be allowed to attend health problems and other genuine exigencies.
- Your entry to the campus and exit from the campus will be monitored. You should carry your ID-Card with you at all time.
- During academic sessions, you are required to be present in your respective classrooms. You will not be allowed to leave the institute's premises during your class hours.

Dress Code: Within campus, all the students are required to be decently dressed, with neat and clean uniform, duly prescribed by the Siddhartha Group Of Institutions. However, on Wednesday the students may report in a decent casual dress.

- You should maintain cordial relations amongst yourselves, with your faculty and staff members.
- A large number of activities will be conducted in groups where you should actively participate for achieving the desired results.
- You need to protect the School's Infrastructure at your service. For any damage caused to the School's infrastructure, it is the responsibility of the students to make good for the same, either jointly or by the miscreants (provided the miscreants are identified).
- Students shall adhere to the norms regarding ANTI-RAGGING LAWS laid down by the Hon'ble Supreme Court of India read as under:

According to the Hon'ble Supreme Court of India ragging includes "disorderly behavior/treatment with fellow student whether by words, spoken or written or by any act which has the effect of teasing, treating and handling with rudeness any other student, indulging in rowdy or indecent activities, which

may cause or is likely to cause physical or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student."

For your information, some of the punishments for students directly or indirectly involved in the ragging and its abatement are as follows:

- Cancellation of admission.
- Suspension from attending classes.
- Suspension/ expulsion from the college and or hostel or both.
- Fine up to Rs. 10, 000/-
- Lodging FIR/Police Action against an offender.

As a measure of preventing ragging we have sent letters to the parents of our senior students so that they can counsel wards for not indulging in ragging of any type. Parents of our senior students are also required to sign the undertaking that they know about the above rulings and the punishments for those who happen to indulge in ragging and that their wards will not indulge in ragging. Similarly, the students are required to give an undertaking that they know the above rulings and punishment for those who happen to indulge in ragging and that they will not indulge in ragging. The format of the letter to the parents and undertaking is given in the following page.

Don'ts

- You must avoid smoking, chewing of Tobacco/ Gutka/ Pan Masala or chewing gum, and consumption of alcohol, within the campus and hostel. Consumption of these products within the campus is prohibited. You are advised to refrain from indulging in these habits even when away from the campus.
- You must avoid use of cell phones in 'ringing mode' during class hours. In exceptional circumstances, urgent/ emergency calls may be taken with permission of concerned faculty.

- Avoid entry in prohibited areas like mess cook-house, electric panel room, D.G Set, sewage treatment plant etc.
- Avoid use of Polyethylene bag in the campus.
- We have systems in the place that would facilitate your smooth functioning. Feel free to discuss any academic or administrative issues with the concerned authority. For academic issues, your contact points in order are: your faculty, Class Coordinators, Head of the Department, and the Director. For administrative issues, your contact points in order are: Head of an Administrative Department (Library, Accounts, Examination and Transport) and the Director.
- We have put in place a comprehensive and transparent student evaluation system. Besides the

external Examination, students are assessed on the basis of class Assignment, Sessional Examinations, and class discipline. Sessional marks of the students are displayed on the notice boards before submitting these to the University so that the students can identify the discrepancy, if any, and bring it to notice of the concerned person.

For this, they should try to use professional managerial thinking for choosing the best solutions out of the various possible alternatives for solving any problem in legal environment.
- The Institute encourages the students to interact with each other and with top personnel in legal, industrial and business organizations to bridge the gap between theory and practice and to enable the students to understand how problems arise and how they are analyzed for reaching solutions in wake of existing constraints.
- We are very particular about attendance in the classes. Students will not be allowed to go on leave, unless there is an extreme necessity and acceptable reason(s). Under special circumstances, a few days leave can be allowed but no benefit of leave will be given in the counting of attendance or for any other purpose related to examination or evaluation process.

- No Student of Siddhartha Group Of Institutions shall indulge in any act of indiscipline which includes:
 - i. Misconduct / misbehavior.
 - ii. Violation of rules and regulations of discipline and SGI directives
 - iii. Breach of an undertaking.
 - iv. Refusal to obey the directions of competent authorities.
 - v. Physical violence or use of abusive language.
 - vi. Destroying or defacing of Siddhartha Group Of Institutions property
 - vii. Organizing a procession or meeting without the permission of the appropriate authority.
 - viii. Rowdy or other forms of misbehavior.
 - ix. Making false statement with a view to affect the impartiality of action by an officer or to impute malice or create public opinion against him / her or with any other malicious motive.
 - x. Participation in activities such as Gherao, Dharna and Pradarshan; Use of derogatory slogans, abuses and propaganda.
 - xi. Disrupting the smooth running of the Institute or environment conducive to studies or harmonious relationship between different people living on the Campus.
 - xii. Refusal to establish or reveal identity.
 - xiii. Non-payment of Siddhartha Group of Institutions fees or other dues including Mess and Canteen charges.

LIBRARY RULE

- No Bags/Hand Bags/Raincoats/Jerkins/Casual Wears/Printed Materials will be allowed inside the Library. Note Books, and Laptops (without bags) however, may be allowed.
- Every reader must sign the Gate Register while entering the Library.
- Students should Keep Silence in the Library. Mobile Phones should be kept in "Silent Mode" while using Library.
- Library timings will be from 8:30 a.m. to 5:00 p.m., but issue/return of books timing will be from 9:30a.m. to 5:00 p.m.

- xiv. Attempting to commit an act of indiscipline, abetting an act of indiscipline, inciting others to commit an act of indiscipline, individually or jointly with others.
- xv. Disrupting or preventing teaching, study, examination, extra-curricular activities, office working etc.
- xvi. Arriving late in classes.
- xvii. Securing admission by submission of fake documents.
- xviii. Sending obscene / lewd / nasty SMS / MMS (Short Messaging Services and Multi Media Services)
- xix. Misuse of internet facilities and mobile phones in the Campus.
- xx. Stealing of Bags/Books or other valuable material.
- xxi. Bursting of crackers and use of colours, dry/ wet, inside the premises including classes.
- xxii. Celebrating birthday (cutting of cake) or any other celebration of a personal nature inside the Campus.
- xxiii. Mass bunking of classes.
- xxiv. Loitering in and around the buildings on the campus/making noise/interfering with peaceful working of Offices, Libraries, Labs and lasses.
- xxv. Over-Speeding and improper parking of vehicles inside the Campus.


for the next 15 days. If the book is still not returned, double the cost of the latest edition of the book will be charged. No book in exchange will be accepted.

- Absence from the Institute will not be accepted as an excuse for the delay in returning of books.
- No reminders will be given to individual defaulters, but a consolidated list of defaulters will be displayed on the Notice Board.
- Books / Old Magazines will be issued to Identity Card holders only.
- In case of marking / underlining / dog-ear of books, the cost of the latest edition of the book will be charged from the student.
- Any violation of the above Rules shall attract disciplinary action.

HOSTEL RULES

GENERAL RULES

- Ragging is strictly prohibited and punishable under law.
- Every boarder has to follow timing fixed for reporting back to the hostel.
- Winter (1 Oct. to 30 Mar) 7:00 pm Summer (1 Apr. to 30 Sept.) 7:30 pm
- Hostlers are not allowed to bring Day Scholars without the written permission of the warden in the Hostel Premises (inside Room, Mess, etc.)
- Always keep your Hostel ID in your pocket to prove your identity, whenever required.
- Playing music at high volume causing disturbance to other inmates is not allowed.
- While leaving the rooms, lights, fans etc. should be switched-off to avoid fine or other punitive action.
- Use of personal electrical appliances, indoor cooking including making of Tea/Coffee/Maggie/Cup Noodles and the like, in the rooms, is strictly prohibited.
- Intoxicants, Liquors, Tobacco, Explosives, Weapons, Obscene materials etc. are not allowed to be kept / stored by the students in the Room / Hostel premises.
- Writing/mentioning obscenity on doors, walls, furniture, switch plates etc. in the hostel premises including washroom walls is strictly prohibited.
- Any type of sexual harassment/ un-natural behavior is strictly prohibited.
- Students shall not hold any meeting or organize any collective activity in the hostel without the written permission of the Warden.
- Use of Loud-Speakers in hostels is prohibited. However, on special occasions, it may be used with prior permission of the Director on the recommendation of Warden. Entry of Loud Speaker shall not be permitted inside the Campus except with the written permission of the Director.
- Celebration of parties, playing with dry / wet colors / plain water in the hostel premises as well as in the Institute Campus is strictly prohibited. However an



COMPUTER LAB RULE

- Timings will be as per the Academic Time Table of respective classes.
- Tea, Snacks, Smoking etc. are not allowed inside the Computer Lab.
- Students are not allowed to use personal Floppies, Pen Drives, CDs etc., in Computer Lab. Only prescribed official, Pen Drives, CDs etc. should be used in the Computer Lab. to avoid VIRUS in Computers. No duplicate or pirated Software(s) are allowed to be used in Computer Labs.
- The equipments should be operated properly and the furniture to be maintained always.
- A student or a visitor who will not follow the above rules shall be fined heavily, even to the extent of expulsion from the program.
- For the benefit of students these rule are subject to change by the order of Director.

event may be organized in a specified area inside the Campus with the prior permission of the Director on the recommendation of the Warden.

- Behaving improperly with Warden/Faculty warden/Asst. Warden/Catering Manager/Waiters/ Security Guards/Hostel Attendants or any other person of the Hostel will be treated as misconduct.
- Canvassing for Membership of Bodies/Agencies (like Avon, Amway, Oriflamme, etc.) or promoting sale and purchase (like cosmetics, soaps, etc) in the hostel is not allowed.
- Students are not permitted to keep excessive cash and valuables with them in their rooms.
- A student should have smart bearing when going out of the hostel always using dress be fitting the occasion and place of visit.
- During the Institute timings, the students should invariably be in their classes/library/computer lab excepting those who are permitted to stay in their respective rooms by the Hostel warden due to sickness.
- A student falling sick or feeling symptoms of sickness should report to the Hostel warden. First Aid is available with the warden. To facilitate evaluation of a sick student to the hospital, necessary arrangements shall be made.

NOTE: Violation of any of the above Rules shall be treated as an act of indiscipline and shall attract disciplinary action.

ATTENDANCE RULES

- All boarders are supposed to report for the Roll Call every day at the notified time i.e 7:30 p.m.
- All boarders are required to be present physically and make a proper queue to record their presence.
- In case of any emergency or illness, the students are required to inform the Warden before the time of attendance.

LEAVE RULES

- No student shall leave the hostel without prior permission of the Hostel Warden.
- Two Out-Passes in a week will be issued on weekdays (excluding Sundays and other Holidays) after 3.30 pm for UG students and after 5.30 pm for PG students. On Sundays, the timings for outing will be 9.00 a.m. to 6.00 p.m.
- No student shall remain absent from the hostel during night, unless he has obtained 'Night-Out Pass' from the Warden.
- Night-Out Permission / Pass to Hostel students will be given on weekends only if the request of the resident has prior approval of the Parents / Local guardians whose photos are given at the time of admission.
- Hostellers taking leave during vacation period should clearly mention address where they are going, telephone numbers, dates and other required information in the Leave Form / Movement Book.
- Students intending to go home during the working days for attending family functions will require permission of the HOD, subject to receipt of written request for the same from parents of the students.
- Day or Night-Out Pass cannot be taken as a matter of routine. Out-pass for Day-outing will be issued only after class hours. Night-Out passes will be issued by the Hostel Warden on satisfying himself about the genuine need of the boarders to stay out.
